3. HAZARDS IDENTIFICATION

Irritant - irritating to eyes.

4. FIRST AID MEASURES

- Eyes :** Rinse immediately with plenty of water, holding the eyelids open and seek medical advice if effects persist.

- Skin :** Wash thoroughly.

5. FIRE FIGHTING MEASURES

NON FLAMMABLE - In the event of a fire due to other causes the product is compatible with water, foam, carbon dioxide and dry powder extinguishers. Firefighters should wear self contained breathing apparatus.

6. ACCIDENTAL RELEASE MEASURES
