SECTION 4: First aid measures

4.1 Description of first aid measures

General Information:

If breathing is irregular or stopped, administer artificial respiration. If unconscious place in recovery position and seek medical advice. Provide fresh air. No mouth-to-mouth or mouth-to-nose resuscitation. Use Ambu bag or ventilator.

Inhalation:

Get medical attention or advice if you feel unwell.

Skin contact:

Wash skin with plenty of lukewarm, gently flowing water for at least 30 minutes. Wash skin with plenty of lukewarm, gently flowing water. Take off immediately all contaminated clothing and wash it before re-use. Immediately call a POISON CENTRE, doctor or physician. If skin irritation occurs: Get medical advice or attention.

Eye contact:

Hold eyelids apart and flush eyes with plenty of lukewarm water for at least 15 minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Immediately call a POISON CENTRE, doctor or physician. If eye irritation persists: Get medical advice or attention.

Ingestion:

Rinse mouth. Immediately drink 1 glass of water. Never give anything by mouth to an unconscious person. Do NOT induce vomiting. Keep at rest. Immediately call a POISON CENTRE, doctor or physician. Get medical attention or advice if you feel unwell.

4.2 Most important symptoms and effects, both acute and delayed

Inhalation:
