

Products are distributed from logistics centers located to optimize transport efficiency using EPA SmartWay* certified carriers to reduce greenhouse gases emissions. Information on the distance of distribution is not available so the PCR hypothesis for "Intracontinental transport", 2175 miles (3500 km) by heavy truck, was used. It is assumed four hole-drillings on the ceiling wall is needed. The model is based on driving a 1.5-HP (1.119 kW) power drill for one minute.


