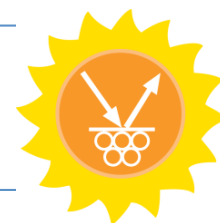

Description: Perfume-free, water resistant SPF30 sunscreen for professional use to protect the skin against the sun's harmful UV-A (ageing) and UV-B (burning) rays.

Method of Use: Apply liberally to clean, dry skin every 2-3 hours, as a minimum, or more often if sweating heavily.

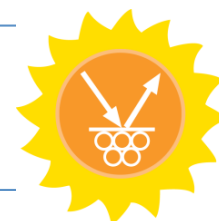

Test Type	Comment
