**Skin Contact:** Not a skin irritant. Low dermal toxicity. Toner is not a dermal sensitizer.

**Ingestion:** Low acute oral toxicity. Exposure not probable with intended use.

**Inhalation:** If symptoms, such as shortness of breath or persistent coughing are experienced, remove source of contamination and move individual to fresh air. If symptoms persist, seek medical attention.

**Skin Contact:** Wash with soap and water. Should irritation occur, seek medical attention.

**Eye Contact:** In case of contact, immediately flush eyes with plenty of water for at least 15 minutes and get medical attention if irritation persists.

<b>Aggravated Conditions:</b>	Exposure to high airborne dust concentrations, including toner, may aggravate existing respiratory conditions.
<b>Carcinogenicity Comment:</b>	Neither this product nor any of its components present above 0.1% are listed by IARC, NTP, or OSHA as known carcinogens.
